THE CONSTITUTION OF THE UNITED REPUBLIC OF TANZANIA, 1977
(CAP. 2)

INSTRUMENT

(Made under Article 90(1))

SUMMONING OF PARLIAMENT

WHEREAS, in accordance with provisions of the Constitution of the United Republic of Tanzania of 1977 and any other law, the General Elections were conducted in the United Republic of Tanzania on the 25th day of October, 2015;

AND WHEREAS, sub article (1) of Article 90 of the said Constitution requires the President to summon a New Parliament within seven days following declaration of the results of the General Elections by the National Electoral Commission;

AND WHEREAS, the results of the General Elections held on the 25th of October, 2015 were declared by the National Electoral Commission on the 29th day of October, 2015;

NOW THEREFORE, I, JOHN POMBE JOSEPH MAGUFULI President of the United Republic of Tanzania, by virtue of powers vested in me under Article 90(1) of the Constitution of the United Republic of Tanzania, 1977, do hereby summon the New Parliament of the United Republic of Tanzania to meet on the 17th day of November, 2015 at the Parliament Assembly Hall, Dodoma, from 9:00 am.
